Educational Sessions

21st Amendment and Supreme Court Roundup

This panel will address recent alcohol-related litigation around the country and highlight important U.S. Supreme Court decisions that could impact regulation in the states.

Coping with the Impact of Deregulation – The U.K. vs. U.S. Experiences

The U.S. and the U.K. have similar cultures, legal systems and marketplace operations. Today, the U.K. is debating new regulations to address widely reported issues including skyrocketing alcohol-related hospitalization and increasing disease rates that have accompanied years of alcohol deregulation. Recent news headlines in the U.S. suggest a movement toward loosening existing alcohol regulations. What can the two countries learn from each other's experiences?

The Latest on Drunk Driving Issues

The nation's efforts to end drunk driving remain critically important for policymakers at all levels. This panel will discuss drunk driving policy from legislative, executive and judicial perspectives.

Antitrust Developments

The current Administration has been increasingly active on a wide variety of antitrust issues affecting many different segments of the economy. After a lengthy investigation, the U.S. Department of Justice (DOJ) recently went to court to block the ABInBev-Modelo merger and settled the case with an extensive divestiture. What does this increased DOJ activity mean for future antitrust enforcement?

Is Regulation Always Bad?

Despite widespread agreement that effective regulation is important to competitive markets, the value of regulating alcohol and other industries is routinely dismissed. The history of regulation, current trends and what they might mean for the future of alcohol regulation will be discussed.

Federal and State Regulator Roundup

At the national level, multiple federal agencies impact or study the alcohol industry, while state regulators face novel issues that vary from state to state. This panel will feature representatives from both federal and state agencies discussing trends and observations from their perspective.

Trade Practices Tutorial

The separation of the tiers in the American alcohol industry has helped create the most diverse and robust alcohol marketplace in the world. This panel will take a close look at specific rules and regulations – and how they apply to trade practices – at both the federal and state levels.

Ethics Roundtable (Eligible for Ethics Credit)

Jack Marshall of ProEthics will challenge attendees with an interesting session examining present day application of laws related to regulated industries, such as ex parte communication issues.

Engaging the Public in Setting Alcohol Policy

Today's system of alcohol policy was established in order to reflect a wide range of voices and opinions on regulation and enforcement, including public health officials, law enforcement personnel, alcohol industry representatives, government officials, consumers and, most of all, the general public. So how does the public impact alcohol regulation? This session will apply examples from other policy issues to show the value of engagement.
